## Cooperation Agreement/Linkage

between

**Dadasaheb Dr. Suresh G. Patil College, Chopda, Jalgaon, India**, herein after referred to as and hereafter referred to as confirming their interest in the development of cooperation in the field of research and teaching to their mutual advantage, have agreed as follows.

### Art. 1

- This Agreement/Linkage sets out the purpose, terms, and conditions of cooperation between **Aditya Poultry Farm, Chahardi Tal. Chopda Dist. Jalgaon**

### Art. 2

- This agreement pertains to teaching, research, and student exchange.

### Art. 3

- Both organizations agree on the following forms of cooperation:

#### **In the field of Education:**

- To exchange experience in teaching methods,
- To exchange staff members for the purpose of giving lectures, taking part in seminars, etc.
- To provide internship opportunities (aligned to NEP-2020) wherever possible to the students.

#### **In the field of Research:**

- To carry out joint research projects,
- To exchange scientific and technical information in coordinating research studies,
- To exchange scientific results in specific fields of science,
- To publish the result in the fields,
- To organize joint seminars, conferences, symposia, etc.

#### **In the field of Student Exchange:**

- To create conditions enabling students to take up master's, Ph.D., or Post-Graduate studies at a partner institution being a part of this agreement.
- To create students for a period of one semester of its part, or for a time needed to carry out a specific project, practical training, or preparation of the thesis,
- To carry out joint research programs by students,
- To exchange students under student traineeship schemes.

**In the field of Consultancy:**

- To provide analytical services, exchange of technologies,
- To conduct Academic/Environmental and Energy Auditing.

**Art. 4**

- In order to achieve specific objectives and tasks under this Agreement, a detailed working plan shall be designed by the internal organizational units. This plan shall refer to this Agreement and shall provide for the rules of cooperation, in particular, such as the method of financing, time and period of the parties 'representatives' visits, and intellectual property rights.

**Art. 5**

- The parties agree to take necessary steps and ensure mutual support for the purpose of raising funds.
- This agreement does not entail any financial consequences for either the parties.

**Art. 6**

- This Agreement enters into force on the day of its signature and will be valid for 5 years.
- If the parties, at least 6 months before the expiration of this period, do not initiate to extend it, this Agreement terminates.
- The Agreement may be terminated upon a prior written notice of termination submitted by the 30<sup>th</sup> of June of the given year with effect at the end of that calendar year.
- All amendments to this Agreement are null and void unless made in writing.

**Art. 7**

- This Agreement is made in English in two counterparts – one for each party.
